## CONDITIONS FOR PROVIDING IVF PROGRAM WITH EGG DONOR AND SURROGATE MOTHER SERVICES

### «VIP GUARANTEE ADVANCED»:

1. Final decision for acceptance of man to program is made by IVF doctor of CHR «Clinic of prof. Feskov»;
2. Medical examinations must be performed in CHR «Clinic of prof. Feskov» only;
3. According to conditions of package, CHR «Clinic of prof. Feskov» provides service of guarantee livebirth of healthy child; in cases of miscarriage independently on term of pregnancy / child death before delivery / child death during delivery, all program will be done until couple will have baby.  
Management of multiple pregnancy (twins) is covered by the contract conditions.
4. Payments according to individual schedule. **No additional payments.**
5. Advantages:
  - no waiting list of surrogate mother for embryo transfer
  - advanced legal support, cooperation up to child registration in residence-country
  - suitable for poor sperm quality, infertility disorders required advanced treatment before IVF
